

Privacy Policy

(version of 1st November 2023)

At DataTech LLC, we care about how any User's personal information is used and shared, and we take the User's privacy very seriously. By visiting the Website and using our Services, the User accepts the practices outlined in this Privacy Policy.

The purpose of this Privacy Policy is to inform the User in a clear, simple and complete manner about the processing of personal data that the User provides or that may be collected by DataTech LLC when the User uses the Website and/or the Services.

The Privacy Policy should be read in conjunction with our General Terms and Conditions (hereinafter referred to as "General Conditions"), so that words beginning with a capital letter have the same meaning in this Privacy Policy as in said General Conditions.

Our policies

We only collect personal information that is relevant to the purpose of the Website and Services. This information allows us to provide the User with a customized and efficient experience.

All personal data collected by DataTech LLC is processed in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27th April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data ("GDPR"), as well as the Swiss Federal Data Protection Act of September 25, 2020 ("FDPA", status as of 1st November 2023).

What information we collect

Users of the Services shall firstly register and create an account through the Website. In order to register or create an account, we may ask the User to provide information, including, but not limited to, that User's name, e-mail address and place of residence. We may retain any written exchanges, e-mails, messages, postings or other correspondence between the User and DataTech LLC to ensure quality control and the best possible service, although we are under no obligation to do so.

In no event will DataTech LLC (i) use this data to market its services or those of a third party, or (ii) sell or transfer it to third parties, or otherwise provide third parties with access thereto, except as specifically provided in this Privacy Policy and/or in our General Conditions.



We may also ask Users to provide a valid credit card number and billing address or other payment information so that we can process any payments for use of the Service by the User, pursuant to our General Conditions. We do not make any credit card information available to anyone except for third party companies we partner with to process credit card payments. We never store any credit card information on our servers.

If DataTech LLC discovers that any personal data has been compromised because of a breach of security, DataTech LLC will promptly notify the User whose personal data has been compromised.

Personal information indirectly collected

DataTech LLC uses cookies and other tracers to collect personal data in order to offer an efficient service. This data may include your connection data, browsing data, IP address, preferences, etc.

How we use your information

We may use personal data and any other information provided by the user through the service for internal purposes only, such as sales, human resources, marketing and administration. We may share this information with third parties who provide us with administrative, IT and payment processing services. If we share information collected from the User with third parties, the use of that information will be governed by their privacy policy.

We may also transfer the User's data to public authorities if duly required for investigating any illegal use of the Website by the User or for other legal proceedings. Personal data may be transferred to criminal investigation authorities in accordance with the applicable exceptions of the GDPR and/or the Swiss FDPA.

Notifications

We reserve the right to notify the User via email, written notices, messages posted to User's account, or notices posted on the Website, as determined by DataTech LLC in its sole discretion or as required by law. By using the Service, the User consents to receive such notices.

Security

DataTech LLC applies organizational, physical and technical security measures for all the personal data it processes. DataTech LLC has implemented protocols and control measures as well as appropriate policies and procedures to ensure the proper application of these provisions, considering the risks associated with the different categories of personal data and their processing. DataTech LLC cannot guarantee that unauthorized third parties will never be able to defeat those measures or use the User's personal data for improper purposes. Hence,



the User acknowledges that he/she provides his/her personal data at his/her own risk.

Modification of Privacy Policy

DataTech LLC reserves the right, at its sole discretion, to change, modify, update, add or remove any part of this Privacy Policy at any time, with or without notice. The User is encouraged to periodically review this Privacy Policy for any changes. The User's continued use of the Services following the posting of any changes to this Privacy Policy constitutes his/her acceptance of such changes, if any.
